

SeaLink offers a freight service on its return ferry service between Townsville and Palm Island.

Please note the following conditions apply to the carriage of freight on board all SeaLink North QLD vessels.

1. All Freight is carried at the Master's discretion
2. SeaLink reserves the right to refuse to carry freight that does not comply with our **Carriage of Dangerous Goods Policy 2019*
3. No alcohol is permitted in the freight trolleys
4. All freight items must be checked in by a SeaLink crew member at the designated Palm Island freight counter
5. On presentation of a valid SeaLink ferry ticket at the freight counter, each passenger is allowed up to FIVE items of dry store freight, as long as each item is less than 20 kg. These items will be assigned an ORANGE freight sticker labelled with the date of travel and will be carried free of charge.
(Hand Trolleys and Prams are not included as freight)
Any excess Dry Store freight (ie more than five items) will be charged at \$7
6. On presentation of a valid SeaLink ferry ticket at the SeaLink ticket counter, each passenger is entitled to **purchase** ONE item of cold store freight as long as the item is less than 20 kg. These items will be assigned a BLUE freight sticker with the date of travel and will cost \$3 per item. (Due to limited cold store availability, these will be allocated on a first in first served basis)
7. Applications for individual SeaLink Dry and Cold store Freight Trolleys will be considered on request on Thursday and Monday services only
8. SeaLink takes no responsibility for any loss or damage to freight

**SeaLink Carriage of Dangerous Goods Policy 2019*

The following items **must not** be carried as freight

- Corrosive substances (e.g: acid, industrial cleaners, pool chlorine, wet cell batteries, engine oil)
- Toxic substances (e.g: oil based paint)
- Flammable/explosive substances or items containing these (e.g: compressed gasses, fuel, combustion engines)
- Radioactive materials
- Bulky/Awkward items (e.g: Sharp objects, glass panels, household furniture/equipment)
- Cement and plaster bags, fertiliser, dirty car parts.
- Machinery/Equipment (unless brand new – as long as oil/liquid has not yet been placed in it; and if Master deems ok with load/pax numbers for the service). Eg: hot water cylinders, generators, BBQ.
